A non-refundable, non-transferable registration fee/deposit of \$350 is due per camper at time of registration. Incomplete registration forms and those not accompanied by payment or signed contract will not be processed.

Early bird discounts are offered on the condition that you pay the full camp fee by **March 2, 2018 (April 1st, 2018 for 14th St. Y Preschool Families)**. **Member rates** are only available if your 14th Street Y family membership is active at time of registration and through the duration of your child's enrollment in camp. **NTDC Sibling discounts** will be applied to the camper with the lowest tuition payment. Sibling discounts across Y camps (for siblings attending New Country Day Camp, On Our Way and Mini Camp) are applied as a 5% discount for each sibling as a way to evenly distribute the discount across the camps.

Please remember to indicate if your child is attending half day or full day. Add up the total due for registration, taking into consideration any reductions for early bird rates, member rates or sibling discounts. All camp fees must be paid in full no later than **May 1, 2018**. If you register after **May 1, 2018**, full payment must be made at time of registration.

If the Y cancels a program, refunds will be issued.

NEW TOWN DAY CAMP CONTRACT – SUMMER 2018 (PLEASE READ CAREFULLY)

Please enroll my child _____ in New Town Day Camp for the summer season of 2018. I understand that a **\$350 non-refundable and non-transferable deposit** must accompany the registration form and this contract.

1. I assume responsibility for paying the balance no later than **May 1, 2018** for my child to attend camp. I understand that in order to receive the **Early Bird discount rate**, all fees must be paid in full by **March, 2, 2018**. (April 1st, 2018 for 14th St. Y Preschool families)
2. I understand that in order to keep the member rate, my 14th Street Y family membership must be active at the time of registration and throughout the duration of my child's enrollment in New Town Day Camp.
3. **Cancelations and refunds: A withdrawal for any reason will cause a forfeit of deposits and fees. There are no refunds or transfer of funds to other Y programs.** Failure to pay in full according to the stated schedules will result in my child being withdrawn from New Town Day Camp program with a complete loss of fees paid. If the Y cancels a program, refunds will be issued.
4. There is a \$20 fee per returned check or reversed credit card.
5. In case of illness, accident, or injury of any kind to the camper while attending New Town Day Camp, permission is granted for the staff to take the camper to a local hospital for emergency treatment. It is understood that the camp staff will make every effort to reach a parent/guardian or emergency contact in the event of illness or injury to a camper. If a camper receives emergency medical attention resulting from an illness, accident or injury at New Town Day Camp, parents/guardians will assume all medical costs.
6. The 14th Street Y reserves the right to request withdrawal of a child at any time during the camp season. In that event, parents/guardians will be responsible for payments covering the portion of the season attended.
7. I understand that The 14th Street Y may photograph and/or videotape my child in New Town Day Camp activities and use these photographs/videos for promotional and archival purposes without any financial obligation to the child or parents/guardians. **If you wish to opt out, please contact the Program Director in writing.**
8. Permission is granted to the staff to exhibit or reproduce any artwork done by the child without any financial obligation to the child or parents/guardians.
9. I will inform the 14th Street Y in writing of any changes in family, address, telephone numbers, e-mail addresses and pick up routines.
